## APPLICATION FOR MEMBERSHIP

Upon receipt of an application for membership, the CFA Executive Director shall request confirmation of the applicant’s status as a firm or corporation actually or directly engaged in the fabrication of structural steel. Either by electronic vote or at a regular meeting of the Board of Directors, final action will be taken on approving or disapproving the application in question. The applicant will be notified of the Board’s decision when finalized.

The undersigned agrees that, if duly elected to such membership, it will at all times during the period which the undersigned shall remain as a member of the Association, abide by the terms of the Association’s By-Laws together with any lawful resolutions adopted by the members of said Association.
